

## Lexicoder Sentiment Dictionary (LSD) Request

Please note that the LSD is available for academic purposes only, and not to private organizations or for profit.

If you are interested in receiving a copy of the LSD, please read the following software license. At the bottom you will need to confirm that you accept this license, fill out a form with your contact information, and send us a brief description of your research.

Note that we will only send copies of the software to email addresses at university or college institutions.

### Software License

This Software License for the program package entitled "LSD" (the "Software"), developed by Lori Young and Professor S. Soroka, from McGill University ("McGill") is granted by McGill, of 845 Sherbrooke Street West, Montreal, QC, H3A 2T5, Canada, to the individual named above, as end user (the "Licensee"), on the following terms and conditions:

#### 1. Grant of License

McGill hereby grants to the Licensee the non-exclusive non-transferable right to use the Software and accompanying manual (the "Documentation") for academic research and education purposes, but not for any commercial purposes whatsoever, on the terms and conditions specified herein.

#### 2. License Fee

McGill grants the License to the Licensee free of charge. The parties hereby acknowledge that the zero fee does not reflect the value of the Software and Documentation. For greater certainty, if more than one person will be using the Software at the same time on one or more computers, the Licensee must obtain additional Licenses for the Software and Documentation. McGill will provide the Software to the Licensee in object code only upon execution of this Agreement.

#### 3. Ownership

McGill retains all property, right, title, and interest in and to the Software and Documentation, including, without limitation, all trade-marks, trade names, copyrights, patents and other intellectual property rights in the Software and Documentation. McGill specifically retains the right to grant licenses of the Software and Documentation to other persons.

#### 4. Transfer Restriction

The Software and Documentation is licensed only to the Licensee, and may not be transferred, and this License may not be assigned to anyone without the prior written permission of McGill.

#### 5. Copy and Use Restriction

The Licensee is permitted to make backup copies and/or to make copies of the Software program on a hard disk, and any such copies together with the original must be kept in the Licensee's possession or control. The Licensee shall reproduce and include the copyright notice of McGill on any and all copies, whether in whole or in part, in any form. The Licensee may not modify, adapt, translate, reverse engineer, decompile, disassemble or create derivative work(s) based upon the Software or Documentation. The Software and/or Documentation may not be rented or leased to others. The Software and Documentation may not be used on a computer network unless only one person can use the Software and/or Documentation at a time.

#### 6. Publications and Presentations

In the event that the Licensee makes any publications or presentations with respect to research conducted using the Software, the Licensee shall acknowledge in such publication or presentation that the Software has been utilized and that the Software was developed at and licensed from McGill.

#### 7. Termination

This License is in force until terminated. This License will be terminated automatically upon reception of a notice to that effect, if the Licensee fails to abide by any provisions of this Agreement, or if any petition, assignment or proposal is made against or by the Licensee under the Bankruptcy Act or if the Licensee is adjudged bankrupt, or makes an assignment for the benefit of his/its creditors. Upon termination, the Licensee shall at McGill's sole discretion return to McGill or destroy all copies of the Software and Documentation. Notwithstanding the termination of this License, Article 9 herein shall remain in full force and effect.

#### 8. Up-date Policy

McGill may produce, from time to time, modifications and/or updates of the Software and/or Documentation. Such modifications and updates may be made available to the Licensee subject to payment of an appropriate fee. However, any such modifications and/or updates will only become available as they are developed, and McGill cannot and does not commit to the development of such modifications and/or updates on any particular schedule.

#### 9. Confidentiality

All information, documentation, script, or object code which McGill may have imparted, or may from time to time impart to the Licensee relating to the Software or Documentation is proprietary and confidential. The Licensee agrees that it shall use the same solely and in accordance with the provisions of this License and that it shall not at any time during or after expiry or termination of this License disclose the same, whether directly or indirectly, to any third party without McGill's prior written consent.

#### 10. Absence of Warranty

(a) The Licensee acknowledges that software in general is not error free and agrees that the existence of such errors in the Software or the Documentation shall not constitute a breach of this License.

(b) There are no warranties, whether express or implied, and McGill disclaims all warranties of

merchantability and fitness for a particular purpose, and any other warranty implied at law or in equity. McGill makes no representations regarding the use or the results of use of the Software and/or Documentation in terms of corrections, accuracy, reliability or otherwise.

#### 11. Limitation of Liability

In no event shall McGill be liable for special, indirect or consequential damages, including those damages arising from loss of profits, loss of revenues or downtime, even if McGill has been advised of the possibility of such damages. McGill's liability on any other claim for loss or liability, including negligence, arising out of or connected with this License, or the Software or Documentation, shall in no case exceed the amount set forth in Article 2.

#### 12. Miscellaneous

(a) This License shall be governed by and construed in accordance with the laws of the Province of Quebec.

(b) This License is drawn up in English at the request of the parties. Le présent contrat est rédigé en anglais à la demande des parties.

(c) This License contains the entire agreement and understanding between the Licensee and McGill with respect to the subject matter hereof and supersedes any prior agreement or understanding whether oral or written, relating to the subject matter of this License. This License may only be modified by a written agreement signed by McGill.
